13 An Emergency Ordinance to appropriate the Town of Fairmount Heights Budget for FY 2000-
14 2001.

16 **WHEREAS**, the Mayor has presented to the Town Council the annual budget for fiscal
17 year 2000-2001; and

19 **WHEREAS**, the Town Council has discussed the budget with the Administration and has
20 made further recommendations.

22 **NOW THEREFORE, BE IT ORDAINED**, by the Mayor and Town Council of
23 Fairmount Heights sitting in Special Session the 28th day of June, 2000, that:

25 I. The property tax assessment as per Prince George's County property tax assessment per
26 owner shall be \$.75 per \$100.00 of assessed property for land and improvements.

28 II. The Mayor's Budget message and all other detailed narrative presented by the Mayor and
29 Council shall be considered a part of this Emergency Ordinance.
