EMERGENCY ORDINANCE

An Emergency Ordinance of the Town Council of Fairmount Heights, Maryland Amending Chapter VII, Licenses, Permits and Miscellaneous Business Regulations, of the Code of Ordinances of the Town of Fairmount Heights, Amending One Section Establishing a Fee Schedule For Business Licenses.

WHEREAS, pursuant to Article 23-A of the Annotated Code of Maryland, and as per the Town of Fairmount Heights, Maryland Charter Article V General Powers, Section 21, Fees and Charges, and Article V Section 33, Licenses, the Town of Fairmount Heights (the Town) has the authority to set fees for business licenses, and to pass such ordinances as it deems necessary to protect and preserve peace and good order, and to protect the health, comfort and convenience of the citizens of the Town: and

WHEREAS, pursuant to this authority, the Town enacted Chapter VII, Licenses Permits and Miscellaneous Business Regulations of the Code of Ordinances of the Town of Fairmount Heights; and

WHEREAS, upon review of Chapter VII, Licenses, Permits and Miscellaneous Business Regulations of the Code of Ordinances of the Town of Fairmount Heights, the Town Council has determined that it would be in the Town's best interest to change the fee schedule established by Ordinance O-03-00 introduced and approved by the Town Council at the 2000-2001 Legislative Session July 19, 2000.

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the town Council of the Town of Fairmount Heights, sitting in Regular Session the 19th day of July, 2000, that Chapter VII, Licenses, Permits and Miscellaneous Business Regulations is hereby amended by changing the following section to read as follows:

S 7-109. License Year; Fees.


(C) The License Fee Schedule Shall Be As Follows:


<u>1. Business with Entertainment</u>	<u>\$500</u>

<u>3. Liquor Stores</u>	<u>\$700</u>
<u>4. Carry Out</u>	<u>\$350</u>
<u>5. Restaurant</u>	<u>\$350</u>
<u>6. Laundromat</u>	<u>\$200</u>
<u>7. Cleaners</u>	<u>\$100</u>
<u>8. Barber Shop</u>	<u>\$150</u>
<u>9. Beauty Shop</u>	<u>\$150</u>


<u>10. Professional Occupations</u>	<u>\$150</u>

<u>15. All Other Business Categories</u>	<u>\$200</u>


BE IT FURTHER ORDAINED AND ENACTED that this Ordinance shall become effective on July 1, 2005 following approval by the Town Council.




