**ORDINANCE**

**Of the Town of Fairmount Heights, Maryland, Authorizing Town of Fairmount Heights Municipal Hall Rental Fees.**

**WHEREAS**, the Charter of the Town of Fairmount Heights, ARTICLE V GENERAL POWERS, Section 1-18. Powers. B. Specific Powers, states The Council shall have, in addition, the power to pass ordinances not contrary to the laws and Constitution of this state, for the following specific purposes: and

**WHEREAS**, Article V, Section 1-18. Powers. B. (21) Fees and charges, states that subject to the limitations imposed by the provision of Article 81 of the Annotated Code of Maryland, to establish and collect reasonable fees and charges.

**NOW THEREFORE BE IT ORDAINED this 21st day of December 2005 as follows:**

1. The Town Council by the authority of the Town Charter of Fairmount Heights established the following fee schedule for Hall Rentals on December 21, 2005:


<b>Meetings/Repasts</b>	<b>\$50.00 per hour plus \$60.00</b>
<b>(Use of kitchen)</b>	<b>\$52.00 - one time fee</b>
<b>Affairs Held Prior to 6:00 P.M.</b>	<b>\$100.00 per hour plus</b>
<b>Opening and Closing</b>	<b>\$ 60.00 (\$160.00)</b>
<b>Two hours</b>	<b>\$100.00 per hour plus \$60.00 (\$260.00)</b>
<b>Affairs Held After 6:00 P.M.</b>	<b>\$125.00 per hour plus \$60.00 ( 4 hours</b>
	<b>= \$560.00)</b>
	<b>(4 hours with kitchen use \$612.00)</b>


**\$25.00 per hour for Police

2. This Ordinance shall take effect December 21, 2005 or 30 days after passage by the Town Council.






