9 **RESOLUTION**

11 Of the Town Council of the Town of Fairmount Heights, Maryland, Appointing Patricia King-
12 Adams to the Unexpired Term for Council.

14 **WHEREAS**, Article VI, Section 1-35 of the Charter of the Town of Fairmount Heights
15 states, "In case of a vacancy on the Council for any reason, the Council shall elect some qualified
16 person to fill such vacancy for the unexpired term.", and further states, "Any vacancy on the
17 Council or in the office of Mayor shall be filled by the favorable votes of a majority of the
18 remaining members of the Council. The results of any such vote shall be recorded in the minutes
19 of the Council;" and

21 **WHEREAS**, at a regular work session of the Mayor and Town Council on April 10,
22 2001, the council voted unanimously to ask the person with the next highest number of votes after
23 the election if they would accept the vacancy for a one-year term instead of two; and

25 **WHEREAS**, the minutes of this action was recorded in the minutes of the April 10, 2001
26 work session of the Mayor and Town Council; and

28 **WHEREAS**, the unexpired term of the vacant Council seat has been offered to Patricia
29 King-Adams, and she has accepted this offer.

31 **NOW THEREFORE BE IT RESOLVED** this 16th day of May, 2001 as follows:

33 1. Patricia King-Adams will fill for vacant Council seat for the Town of Fairmount
34 Heights Council.
35 2. The Term of office shall be for one (1) year, and that term will expire in May,
36 2002.
37 3. This Resolution shall take effect upon passage by the Mayor and Town Council.
