RESOLUTION

A Resolution Adopting the Revised Rental Agreement for the Entertainment Facility and Other Matters

WHEREAS, the Town's Municipal Center contains an Entertainment Facility on the ground level suitable for rentals for small functions; and

WHEREAS, many in Town make use of the facility for family-related and other functions; and

WHEREAS, the income from the rental of the facility can be used to defray the Town's expense; and

WHEREAS, Members of the Town Council and the Town's Administrative Staff may be interested in scheduling use of the facility from time-to-time

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF FAIRMOUNT HEIGHTS THAT:

SECTION 1. The revised and rental agreement, updated 4/9/07, be used to ensure that renters understand their responsibilities and that the Town be held harmless in any case involving injury or illness resulting from a renter's activities.

SECTION 2. Members of the Town Council and Administrative staff members are authorized to rent the facility at a 50 percent discount on the base rate for the type of function for which the facility is rented, all other fees remaining applicable.


SECTION 3. Members of the Town Council may rent the facility once a year for a nominal fee of \$1.00 to constitute a legitimate contract involving a fee for services and to ensure applicability of the "hold-harmless" clauses, all other fees being applicable.


