RESOLUTION

A Resolution to Reconstitute the Membership of the Town's Ethics Commission

WHEREAS, Chapter II Article 1. of the Code of Ordinances of the Town of Fairmount Heights outlines the Town's Code of Ethics and

WHEREAS, elected and appointed officials and employees of the Town are governed by the tenets of the Town's Code of Ethics; and,

WHEREAS, oversight of adherence to the Code of Ethics is vested in an Ethics Commission designated by the Mayor and confirmed by the Town Council; and

WHEREAS, the Mayor, with the approval of the Council, is authorized by Section 1-17 of Article IV, of the Town's Charter to make necessary appointments to meet the needs of the Town and its responsibilities enumerated in the Charter and its Code of Ordinances; and

WHEREAS, the Mayor has determined that a fresh approach and new personnel are warranted to actively oversee and, where necessary, enforce the responsibilities of the Ethics Commission, consistent with and within the operating framework envisioned in the Code of Ordinances

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF FAIRMOUNT HEIGHTS THAT:

SECTION 1 The Council concurs in the Mayor's decision to reconstitute and re-invigorate the Ethics Commission.

SECTION 2. The Council has interviewed the Mayor's candidates for appointment to the Ethics Commission and concurred with the Mayor's choices.

SECTION 3. The new Ethics Commission Members will be Mr. Alvin Austin, Mr. Michael Hairston, and Ms. Francine Wallace.

SECTION 4. In accordance with Section 1-12 of the Town Charter, this Resolution shall become effective 20 days after its passage.
