RESOLUTION

A Resolution to Enter into a Contract with Cintas Corporation to provide "Sinus Ultraclean" Services for Restrooms in the Municipal Center

WHEREAS, the restrooms in the Municipal Center of the Town of Fairmount Heights are open to the public and are used by the staff and others; and

WHEREAS, the equipment used by the Town's crew to clean the restrooms is woefully inadequate to maintain the levels of cleanliness desired by staff members and the public who use the facilities and renters of the entertainment facility on the lower level; and

WHEREAS, the quality of care afforded by the Cintas system can dramatically decrease exposure to disease carrying agents; and

WHEREAS, until funds are obtained to repair and upgrade the restrooms, we will continue to have problems with the cleanliness of the facilities; and

WHEREAS, retiling damaged portions of the upper level men's room is required before the room can be considered able to be "cleaned;" and

WHEREAS, the cost of the Cintas contract – approximately \$200.00 per month - is considered nominal given the change in level of cleanliness and perceptions of the facility by employees, visitors and renters.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF FAIRMOUNT HEIGHTS THAT:

SECTION 1. The Mayor is authorized to enter into a maintenance agreement with Cintas to provide restroom cleaning and disinfectant services on a monthly basis after damaged floor tiles are replaced in each restroom requiring repairs.


